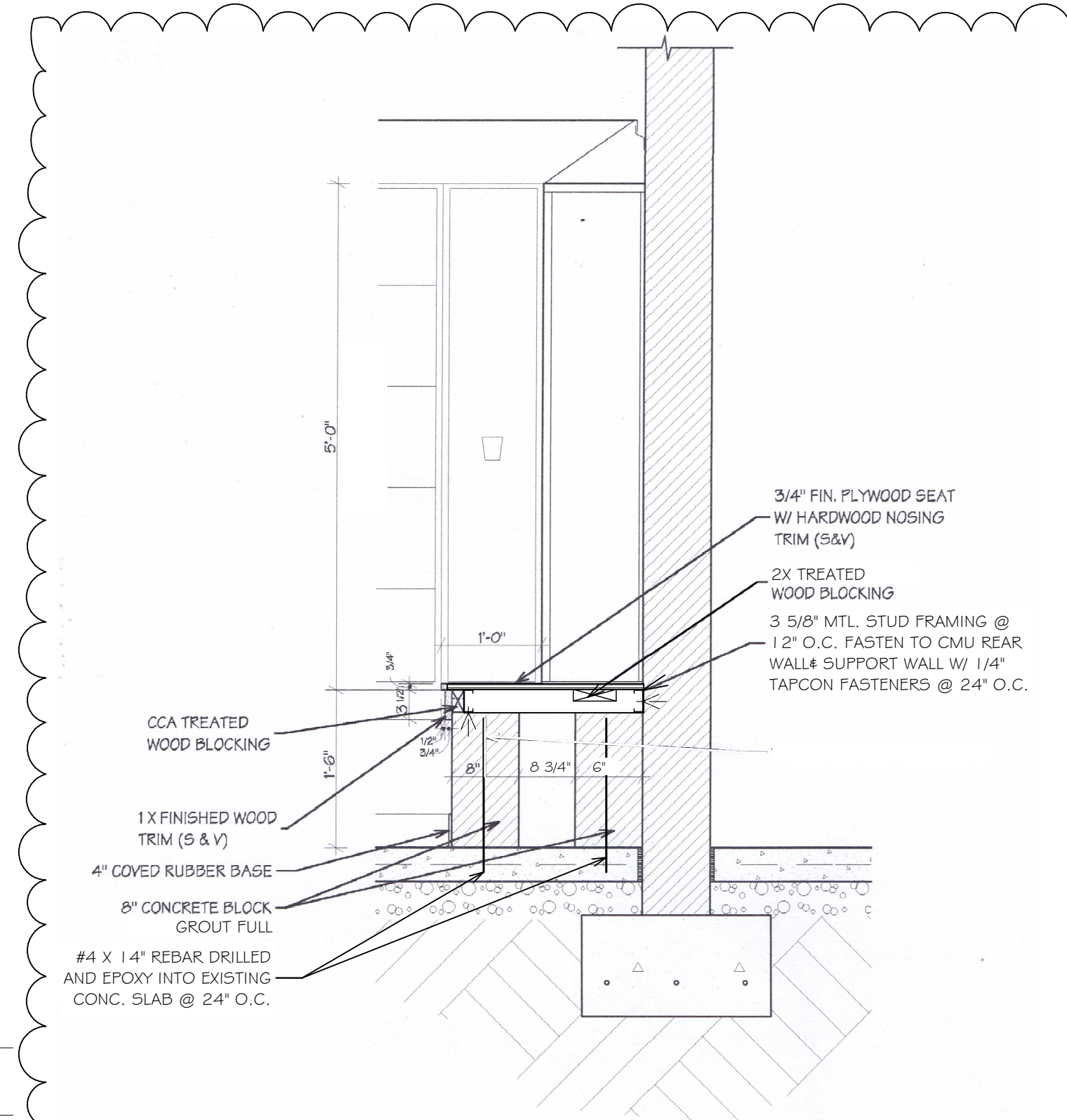

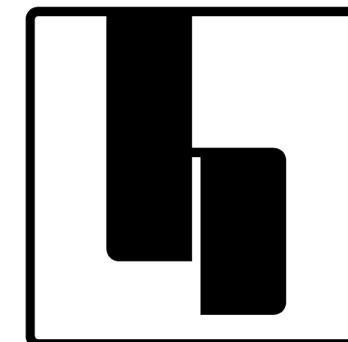


DETAIL AT PLATFORM S104C

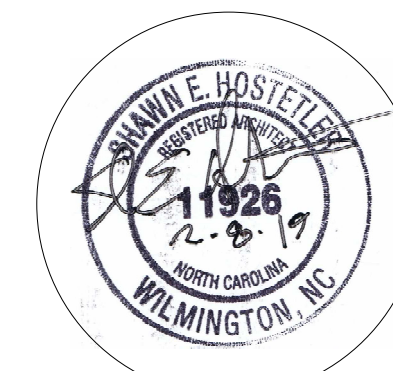
