The following have been added by full text:

AMEND 0007

1. **QUESTION:** Drawing M-602 calls for "platforms that connect boilers together giving 2 means of egress from platform." However, there is no layout for the platforms provided. Can you provide the boiler platform layouts, please? Is it possible that we can field erect platforms after boiler installation?

ANSWER: Please see attached boiler platform layout. Platform may be field erected after installation. Platform must be in place before boiler startup.

2. **QUESTION:** RFI item #58 in Amendment #6 can be read two different ways and is very vague. Does item #58 state: "Delete all work associated with the Pharmacy which is served by Air Handling Unit #32" or "Delete all work associated with the Pharmacy and everything associated with Air Handling Unit #32." The drawings do not identify which rooms are associated with the Pharmacy. Please identify which rooms are "associated" with the Pharmacy, or are we to simply to delete all work associated with Air Handling Unit #32?

ANSWER: Delete all work associated with Air Handler 32.

3. All other terms and conditions remain unchanged.
