NOTE: Proposals submitted with "Assumptions" will not be accepted; therefore, utilize the attached "Request for Information" form (RFI) when submitting questions. The form shall be submitted via email to the undersigned. All RFIs shall be submitted as soon as possible to allow sufficient time to prepare a response. RFIs submitted less than **five work days** prior to the due date may not be answered. (Please submit in **WORD format, Times New Roman 12 pt font**). If the RFI is not properly formatted as stated, it will be returned to you without action. Each form submitted shall be numbered sequentially on the form by the contractor for tracking purposes.
