Projects located in other zoning jurisdictions within the county may be subject without further notice to similar penalties for violation, in addition to the penalties otherwise authorized by law. I am aware that the North Carolina General Statutes 153A-363 states that occupancy of a building without a "Certificate of Occupancy" constitutes a misdemeanor.
