Introduction

The Home2 Chelsea and Tribeca prototypical décor packages have been thoughtfully designed and carefully vetted by Hilton. This current set of specifications replaces the previous "design intent" specifications with no changes to the overall aesthetic quality. The suppliers and their products were chosen after an extensive and rigorous vetting process and represent a high quality, more economical and streamlined solution for Home2. The package is pre-approved and if used in its entirety may help expedite project approvals. Refer to Project HUB for submittal requirements.

Within this document are the specifications needed to implement a Home2 Suites Brand guest room scheme. Along with the Design Brief, the Home2 Suites Brand Standards Manual and the Architectural Prototype Drawings, these specifications will assist the designer in completing either a new build or renovation Home2 Suites Brand property.

The specifications are divided into two sections: Specifications and Finishes. The prototypical specifications coordinate with the current Home2 Suites Brand prototype room types. For renovations, designers will use the prototypical specifications. The finish portion provides specifications that act as a guide to selecting the materials needed for a complete guest room.
